**CIRCULAR**

**Sub: Third Party Audit of Pro active discloser under Section 4 of the RTI Act, 2005.**

Please find enclosed herewith the Ministry of I&B vide letter No. R-11013/5/2017-RTI dated 01.07.2019 alongwith Central Information Commission vide letter D.O 6/1/20163/JS(LAW)/CIC-V/2018/176-215 dated 18.06.2019 on the subject cited above.

2. In this connection, it is informed that section 4 of the Right to information Act, 2005 provides that it is an obligation on the part of a Public Authority to provide as much information **Third Party Audit of Pro-Active disclosure under Section 4 of RTI Act, 2005** to the public at regular intervals through various means of communications, including inter-net, so that the public have minimum resort to the use of this Act to obtain information. Therefore, for successful implementation of the above said Act, it is felt necessary, at this stage, to review information already uploaded on DG:DDn website so as to ensure proactive disclosure under Section 4 of RTI Act, 2005.

3. It is also informed that RTI Cell vide its Circular dated 06.08.2018 requested all the Divisional Heads of Directorate General, Doordarshan Kendras/HPTs/DMCs/Zonal offices/News/CPIOs/FAAs etc. to upload maximum information as provided under Suo-Motu disclosure under Section 4 of RTI Act, 2005, but response received so far is not satisfactory. Posting/uploading maximum information on the website may not only support the functioning of the Doordarshan more transparent but also reduce the need for filing individual RTI applications on a particular area.

4. Therefore, all Section Heads/Division/Zonal Incharges, Head of Office of Kendras/DMCs/HPTs, etc. are requested to upload maximum information as provided under **Suo-Motu disclosure under Section 4 of RTI Act, 2005 on the RTI Portal of Doordarshan and submit an Action Taken Report to the RTI Cell along with soft copy, so that same could be updated and forwarded to the CIC & Ministry of I&B for information.**
