

OFFICE MEMORANDUM

The undersigned is directed to convey the following to kendras for necessary action at their end:

Carpenters , Painters and Tailors got the benefit of CGIT Award which states that

“The Carpenters and painters are entitled to the same pay scale which is applicable to the Floor Assistants from 21.2.2005 and they are entitled to get arrears also. Their claim for revision from initial date of employment is not maintainable in view of their inordinate delay. The management should consider the case of carpenters and Painters and should try to place them on the pay scale of the Floor Assistants based on seniority w.e.f 21.02.2005.”

In compliance of CGIT award Screening Committee recommended the proposal of grant of ACP to 82 Carpenter/42 Painters/15 Tailors and as duly approved by DG:DD the award was granted to them vide DG:DD OM No.35/20/99-SI dated 01.02.2012 and order No.5/13 dated 16.01.2013 issued from file No.7/1/12-SI. Later on many more were also granted the benefit of CGIT award

In compliance of CGIT award, DG:DD has granted first ACP w.e.f 09.08.99 instead of 21.02.2005 vide the above mentioned OM resulting in notional increments from 09.08.99 to 21.02.2005.

PAO has raised objection in cases of Retiring Officials stating that the pay should be fixed same as that of Floor Assistant on 1st ACP w.e.f 9.8.99 in the scale of 4500-125-7000 then from 21.02.2005 at par with Floor Assistant i.e. 6500-200-10500. The PAO observed that as per CGIT award that the pay of Carpenter / painter to be same to that of Floor Assistant w.e.f. 21.2.2005. However 1st ACP benefit has been granted to Carpenter / Painter on notional basis in pay scale of 6500-10500 which is not consistent with the CGIT award. On the basis of these objections, the pay was refixed and recovery made from some of the incumbents at the time of their retirement.

In near future, many of the carpenters /painters/Tailors may retire and same issue of overpayment will be raised by PAO at the time of retirement. To avoid repercussions on employees and Department, it is directed that para 5 of page 2 of OM dated 01.02.2012 issued from file No.35/20/99-SI may please be read as under and fixation of pay may please be carried out accordingly:-.

“The financial upgradations already received by Carpenter/ Painter / Tailor prior to 21.02.2005 i.e. cut off date for implementation of CGIT award will be maintained as in accordance with the rules of ACP However their pay will be fixed according to CGIT award be placed at par that of Floor Assistants w.e.f 21.02.2005 only and not on notional basis in the scale of 6500-10500. However, they will be entitled for arrears of pay in lieu of fresh financial upgradation w.e.f 21.02.2005 only”.

On these lines Head of Kendras are directed to issue show-cause notice to the beneficiaries of CGIT award . Accordingly their pay to be fixed and excess amount be recovered under intimation to this Directorate. ATR may be sent to this Directorate. The matter may be accorded Top Priority.
