
Subject: Furnishing of legacy data pertaining to NPS - reg.



Subject: Furnishing of legacy data pertaining to NPS - reg.

Reference is invited towards PB Sectt. letter dated 06.07.2020 on the subject mentioned in which a total of remaining 45 subscribers are pending whose NPS(National Pension System) legacy data has not been processed till date who are posted across various stations/kendras/DMC's/HPT's etc across the DD network.

2. The matter has been viewed very seriously by Prasar Bharati Secretariat and by ADG(Admin) in this Directorate. Contribution of NPS in PRAN Account is very important for NPS employees working in all over India. The list of remaining subscribers was 81 as on 16.12.2019 and as on 06.07.2020, the list contains 45 remaining subscribers.
3. Earlier, ADG(Admin) had also been sent DO letters to all Zonal ADGs to take up this issue with the concerned DDO's. However, it seems that no concrete action has been taken till date by some of the DDO's. However, few DDO's have successfully cleared the NPS legacy data.
4. Therefore, All concerned DDO's are requested to furnish the NPS legacy data as per ANNEXURE-I (enclosed) to the concerned PAO's within one week from the issue of this letter otherwise Prasar Bharati may withhold the LOC of the DDO's concerned. The requested information may be directly sent to Prasar Bharati Secretariat's NPS Section by post or by email (on their mail pbmps123@gmail.com) under intimation to this section by post or by mail (at ddsohris@gmail.com). In case of no NPS legacy data in r/o employees under NPS exist, a 'NIL' report may also be submitted at the earliest.

Parameters taken in the prescribed format-

1. It has been assumed that in cases where the difference between date of joining & date of activation of PRAN is less than 100 days, the NPS contribution for such period is uploaded by the concerned DDOs at their end and no legacy is created.
2. The provision equivalent to the fund balance in CPF account has been mentioned due to possibility of the following:
 - a) Cases having less than 100 days difference between date of joining & date of activation of PRAN.
 - b) Pending NPS legacy even after activation of PRAN.
 - c) NPS legacy of employees with inactive PRANs.
 - d) NPS legacy with more than one DDOs.
 - e) Pending NPS legacy in cases where employees have left Prasar Bharati. (Unmapped PRANs)
