NOTICE

Empanelment of Stringers in Regional News Unit Doordarshan Kendra, Bhubaneswar

The Regional News Units, Doordarshan Kendra, Bhubaneswar invites applications for empanelment as Stringers / Cameramen from Proprietor / Partnership firm /Corporate body / Organization with experience in coverages.

Stringers are required in all 30 districts and Major towns of Odisha viz. Bhubaneswar, Cuttack, Puri, Rourkela, Brahmapur, Paradip, Sambalpur, Jeypor, Baripada, Talcher. The applicants must mention in the application form the name of the district/city where they wish to be empanelled. The existing PTCs of AIR, Cuttack may also apply, if they are interested for empanelment as Stringers of Doordarshan of their respective Districts.

Existing Stringers of Doordarshan, Bhubaneswar shall apply afresh and they will also have to undergo the process of empanelment. Empanelled Stringers are expected to do news coverages and short features on news, current affairs, sports, business and other subjects. Applicants equipped with four-wheel vehicles, should have qualification, experience and expertise in cinematography /videography / newsgathering / broadcast journalism. Details of other terms and conditions prescribed in Guidelines issued by Directorate General, Doordarshan, New Delhi vide their Memo No. 3/4/2003-P-III dated 02.07.2010 duly uploaded.

Applications duly supported with Demand Draft drawn from any nationalized bank after publication of this advertisement tuning to an amount of **Rs. 1000/- (Rupees one thousand)** only towards non-refundable processing fee in favour of the “**Drawing and Disbursing Officer, Doordarshan Kendra**” payable at Bhubaneswar.

Applications duly filled in along with its enclosures in triplicate should be submitted in sealed cover with superscription on the top of the left corner of the envelope “**Empanelment of Stringers- Name of the District / city - -----**” to the Joint Director(News), Regional News Unit, Doordarshan Kendra, Bhubaneswar, 751005 by **SPEED POST/REGD. POST. Last date of receipt of Application is 31st August, 2020.**

N.B.

1. Incomplete applications without processing fee & dossiers in support of educational/professional qualifications will not be considered for candidature.
2. No TA/DA will be admissible for appearing the interview.

Present payment rates to Stringers :

At presents Stringers will be paid for local coverages of irrespective of length of footage or its usage but inclusive of transportation and delivery charges for (i) local coverage of duration of 6 hours @ Rs.1500/- (one thousand and five hundred) only per coverage and in case it exceeds more than 6 hours duration and when it involves location apart for more than 10 km, it will be treated as second coverage will be paid @ Rs.1000/-(One thousand rupees) only.

(ii) in case of outstation coverage, which are coverages undertaken beyond the geographical limit of the town/city where the Stringer is empanelled and stationed or beyond the town, the Stringer's fee would be Rs1800/-(one thousand and eight hundred)only irrespective of length of the footage or usage of the coverage, inclusive of transportation and delivery charges. The present annual maximum ceiling limit is rupees four lakhs.

Stringer should have own camera (latest), adequate facilities and equipment to undertake the coverages. Those equipped with 4-wheel vehicles and mobile phones will be preferred. Proof of ownership of the camera and equipments must be submitted at the time of interview. A physical verification of the equipments and ownership documents will be verified at the time of interview.

The coverages by a Stringer should contain all elements of a NEWS STORY. For each coverage, the Stringer should provide raw footage, dope sheet, press material and a script, Stringers should not only cover assigned tasks but also alert the RNU on major News fall/breaking News/stories of human interest in their area. The assignment of stories to Stringer depends on need & requirement of News Bulletins.

The Panel of Stringers shall be revised every two years.

Stringers will be removed from the panel on all or any of the following grounds :

1. When the Stringer refuses to cover the assigned coverages on two or more occasions;
2. If the coverages are poor in content or in technical quality (poor audio quality, noisy video, variation in luminance level, defocused pictures, etc.);
3. Delay in providing timely coverage;
4. When the Stringer is suspected to be sub-contracting the assigned work to others;

5. If the Stringers are found to be operating a cartel system among themselves;
6. If the information furnished by the Stringer in the application form for empanelment is found to be incorrect.
7. Any act on the part of the Stringer which creates embarrassment to Prasar Bharati.
